

**OREO PUFFS™ Cereal Milk Fridge Sweepstakes
Official Rules**

1. **ELIGIBILITY:** The OREO PUFFS™ Cereal Milk Fridge Sweepstakes (“Sweepstakes”) is open only to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older (or the age of majority in the jurisdictions in which they reside if majority age there is greater than 18) as of date of entry. Boxes), email address, birth date, and phone number. You will receive one (1) entry into the Sweepstakes subject to the limit below.

Optional method of entry. Share Method of Obtaining Additional Entries: After entering as set forth above, you may obtain additional Sweepstakes entries by using the share functionality provided to post a prepopulated message promoting the Sweepstakes on your personal Pinterest Account, X Account, and/or via email to invite a friend to enter the Sweepstakes. For each share message sent using the share functionality provided where the individual who receives the message uses the unique link and enters the Sweepstakes, you will receive one (1) additional entry into the Sweepstakes. You may receive up to a maximum of fifteen (15) total additional entries across all combined

platforms/methods described herein as the optional share methods (social sharing and email sharing). All shares are subject to the applicable platform's terms of service, conditions, and policies.

The Sweepstakes Parties are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

6. **WINNER NOTIFICATION/PRIZE CLAIMING:** Each potential winner will be notified via email at the address provided on the entry form in a commercially reasonable time after the drawing. The Sweepstakes Parties are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in entrant's email or other account to receive messages. Notification is deemed to have occurred immediately upon sending the email. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.

7. **PRIZES/PRIZE RESTRICTIONS:** The prizes to be awarded in this Sweepstakes are:

Three (3) Prizes: Each winner will receive an OREO PUFFS™ Cereal wrapped milk dispenser, a pantry restock of OREO PUFFS™ Cereal (consisting of 2 cases), and a \$100 prepaid card. The approximate retail value (“ARV”) of each prize is \$1,500.

The total ARV of all prizes available in the Sweepstakes is \$4,500.

Prepaid cards are subject to the issuer’s terms and conditions, and will not be replaced if lost, stolen, or damaged. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another Party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Minnesota. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either Party may, notwithstanding this provision, bring qualifying claims in small claims court.
- 14. - 15. MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain

in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
